

CONSENT of a Website Visitor to the Processing of Personal Data

I, the Personal Data Subject, acting in compliance with Federal Law No. 152-FZ dated 27 July 2006 “On Personal Data”, as amended, hereby freely, voluntarily and in my own interest, and confirming that I have full legal capacity, give my consent to Resol Limited Liability Company (Taxpayer Identification Number (INN) 7814408105), hereinafter referred to as the “Operator”, whose website is available at <https://resol.pro> to process my personal data subject to the following terms and conditions.

1. This Consent applies to the processing of personal data both by automated means and without the use of automated means. I consent to the processing of the following personal data: name; telephone number; email address.

2. I have been informed that the following documents constitute the basis for the processing of personal data: the Personal Data Processing Policy; this Consent to the Processing of Personal Data.

3. The legal grounds for the processing of personal data are Article 24 of the Constitution of the Russian Federation, Article 6 of Federal Law No. 152-FZ “On Personal Data” and this Website Visitor’s Consent to the Processing of Personal Data.

4. I have been informed that, in the course of processing personal data, the Operator may perform the following operations: collection, recording, organisation, accumulation, storage, rectification (updating or modification), retrieval, use, transfer (provision or granting of access), anonymisation, restriction, erasure and destruction of personal data.

5. I confirm that the Operator has explained to me the consequences of failing to provide personal data where the provision of such data is mandatory under federal law.

6. I have been informed that I may withdraw this Consent by contacting the Operator in person or by submitting a written request to info@resol.pro.

7. I have been informed that, upon withdrawal of this Consent, the Operator may continue processing my personal data without my consent where any of the legal grounds set out in Article 6(1)(2)–(11), Article 10(2) or Article 11(2) of Federal Law No. 152-FZ dated 27 July 2006 “On Personal Data” applies.

8. I have been informed that this Consent shall become effective when it is provided (submitted) to the Operator and shall remain effective until the processing of personal data is discontinued. The validity period of this Consent is five (5) years. The date and time on which I click the relevant button to submit a completed form on any page of the Operator’s Website shall be deemed the date and time on which this Consent is executed, confirmed and submitted.

9. This Consent shall terminate upon the occurrence of any of the following events:

- expiry of the validity period of the Personal Data Subject’s Consent;
- achievement of the purposes for which the personal data are processed;
- withdrawal of the Consent by the Personal Data Subject;
- identification of unlawful processing of personal data.

10. I have been informed that, in all matters not expressly governed by this Consent, the Operator and Personal Data Subjects shall be governed by the applicable laws of the Russian Federation and the Operator’s Personal Data Processing Policy, which is permanently available online at <https://resol.pro>

11. I hereby confirm that ticking the box marked “I consent to the processing of my personal data in accordance with the Personal Data Processing Policy” and clicking the button to submit the completed form on <https://resol.pro> constitutes a sufficient form of consent and enables the parties to verify that such consent has been obtained. No additional evidence shall be required to confirm that I have freely expressed my consent.
